Purpose

The UK Playwork NOS Consortium is a partnership of the national play and playwork organisations: Play Wales, Play England, PlayBoard Northern Ireland, Play Scotland and the Playwork Foundation. The consortium has been approved by the UK Standards and Frameworks Panel to undertake a self-funded review of the National Occupational Standards for Playwork on behalf of the UK playwork sector.

The NOS writing group will be supported by various Expert Reference Groups (ERGs). The purpose of the ERGs will be to act as a critical friend to the NOS Writing Group and UK Playwork NOS Consortium. The NOS writing group will be a group of committed sector experts who will take forward the work of writing new NOS for playwork during 2024/25. Due to the intensive nature of the work and the requirement for consistent attendance and focus we are looking to recruit a maximum of eight members. Role of Expert Reference Groups

The Expert Reference Groups will meet two or three times during the NOS development process and will help to shape the draft NOS standards before they are shared for wider consultation. The role of the ERGs will be to ensure the resulting standards reflect the broad and diverse requirements of the playwork sector across the UK.

It is anticipated that the ERGs will meet:

- 1. near the start of the development process
- to provide feedback on the functional map which provides a broad overview of what the standards will cover
- 3. to provide feedback on the final standards before wider consultation.

Whilst experience of developing NOS and/or qualifications is important, we are also keen to build knowledge and capacity in the sector for future NOS reviews. For this reason, we welcome applications from potential ERG members who have not been involved directly in this work before.

We are still developing the ERGs but intend to have groups covering the following sub-sectors:

- play and playwork in Higher Education
- further education qualification providers and awarding bodies
- open access playwork
- out of school childcare
- playwork in other contexts including youth work, health, hospitals, prisons, education and schools.
