Engagement A: What further changes would you like to see within the National Minimum Standards statutory guidance to support the <u>Early Childhood Play</u>, Learning and Care (ECPLC) vision

Supporting comments:

We know from feedback, that when those involved in ECPLC provision undertake playwork training or qualifications, it benefits their practice. We would welcome discussion about additional guidance that links the playwork approach, underpinned by the Playwork Principles, with the core principles of ECPLC (Enabling Adults, Effective Environments and Engaging Experiences).

Engagement B: Do you have any other comments with regards to the chapter 'What do we mean by High Quality Provision'?

Supporting comments:

We would suggest it references 'minimum standards,' rather than 'minimum or basic requirements' – for consistency of language.

The reference to 'continuous improvement' would be strengthened by some qualifying statements. In some cases, continual improvement is not possible, this may be due a range of factors including: movement of staff, cultural or social factors and funding. Reference to maintaining quality and working proactively to identify actions to avoid a reduction in quality would address this.

 Your views are sought on whether there are any other amendments the Welsh Government should make to the standards.
In the Review, recruitment and retention issues were noted as a problem across the sector. Therefore, in the last refresh of the NMS in 2023, we updated childcare qualifications requirements for day care providers under Standard 13: Suitable person (DC)) – to allow 20% of staff in full day care settings and 10% of staff in sessional or open access play settings who are working towards a qualification to be included in the staff qualification ratios (with conditions applied).
Engagement Question H: Do you have any comments on the current working towards requirements?
Supporting comments:
We are supportive of greater flexibility in relation to 'working towards' qualifications. However, this could cause confusion for open access settings especially in light of the proposed changes in Question 7 regarding qualifications. 50% of all other staff can now be unqualified and 50% require a level 2 qualification. It is not clear how this 10% would work for the 50% of staff who require a level 2 qualification. It is unlikely that most settings would have enough staff on site for this 10% to be a whole person. This needs further consideration.

Supporting comments:

The Ministerial Review of Play called for greater proportionality with regards to regulation and inspection. We remain optimistic that some of the proposed changes will help with this. These are changes that we have called for over the last ten years or more. It is important to emphasise the important overlap and interrelatedness between the proposed changes to the NMS, the Exceptions Order regulation changes (which are proving very complex) and the proposed approval scheme. As well as these consultations there is the addition of bespoke NMS for open access playwork and the ability to register multiple sites under a single registration. Some of these changes are very complex and it remains to be seen as to how they will impact on setting registration for open access playwork and the inspection process. We are keen to continue to work with the sector and the Welsh Government to monitor this to work towards the aspiration of a more proportionate approach that safeguards children and still ensures quality.
